In case the last submission date falls on a public holiday, the documents may be submitted during office hours on the next working day.

1. The Bidders who have already submitted sealed tender bids in response to the first date of publication can either revoke them or continue by sending a letter.
2. The Bidder should be a registered company at their respective legislation.
3. The Bidder should have minimum One year of experience in implementation & execution for complete Reconciliation solution for Card Transaction, ATMs and other transactions in at least one commercial Bank, handling reconciliation operations. Bidder must have conducted reconciliation operations for at least one commercial Bank in the last two years.
4. The Bidder must have technical support Centre in Nepal. They should have capability to support Bank's Data Center (DC) and Disaster Recovery (DR) respectively.
5. The proposed software should be able to integrate seamlessly with systems for reconciliation (CBS, Card Management System, ERP, GL, Payment Gateways, Switch, Omni Channel etc.)
6. The Bidder must not be currently debarred or blacklisted by any bank, Nepal Rastra Bank (NRB), any other regulatory authority, or financial institution in Nepal as of the date of RFP submission.
7. Eligible Bidders should submit all the documents outlined in the RFP document and failing to do so shall result in the rejection of the bid submitted by the bidder.
