

INVITATION FOR SEALED TENDER BIDS

Description of works: NMB Bank Limited solicits sealed Tender bids from interested and eligible bidders for Supply and Delivery of F5 Advanced Web Application Firewall.

- B. The tender bid shall consist of a sealed technical bid and a sealed financial bid, as described in the "RFP Document," in accordance with the schedule given below:

- C. The bidder must be a legally registered company under the applicable laws of their respective country.
- D. The bidder must be registered with the tax authority of their respective country, such as possessing a valid PAN or VAT registration.
- E. The bidder must be a F5 Partner or an authorized vendor for selling F5 products in Nepal.
- F. The bidder must have successfully delivered at least two (2) F5 AWAf solutions within the last three (3) years to any Class "A" Commercial Bank in Nepal. An appreciation letter or equivalent documentary evidence must be submitted to support this claim.
- G. The bidder must have at least two (2) F5 WAF-certified engineers on its current payroll.
- H. The bidder must not be involved in any corrupt practice and must not have been penalized by any authority for violations of anti-money laundering laws or policies in any jurisdiction.
- I. The bidder must not be currently blacklisted by any bank or institution in Nepal or abroad.
- J. The bidder must comply with all prevailing Anti-Money Laundering (AML) laws of Nepal.
- K. The bidder must comply with all prevailing environmental and labor laws of Nepal.
- L. Eligible bidders must submit all documents outlined in the RFP document. Failure to do so shall result in the rejection of the bid.
